TEMIR Privacy Policy

TEMIR LLC has created this Privacy Policy ("Policy") in order to set out how we collect, use, and disclose personal information through the TEMIR websites located at temir.ae and (the "Websites") and our TEMIR services, which allows users to share Account information and Personal Information for business networking purposes through the use of a smart chip card (together with our Websites, the "Services").

The privacy of our users is of great importance to us. By using the Services in any manner or providing Personal Information to TEMIR, you acknowledge that you accept the practices and policies outlined in this Policy and you hereby consent to the collection, use and disclosure of your Personal Information in accordance with this Policy.

1 WHAT DOES THIS POLICY COVER?

This Policy covers our collection, use and disclosure of information about identifiable individuals ("Personal Information"), particularly those individuals who use our Services ("Users"), as well as customers and prospective customers.

This Policy does not apply to the practices of companies that we do not own or control, including those practices of third-party organizations or individuals with whom you choose to share Personal Information. You should review the applicable privacy policy of any company with which you do business. We do not knowingly collect or solicit Personal Information from anyone under the age of 13.

2 COLLECTION AND USE OF PERSONAL INFORMATION AND OTHER DATA

Users may be required to have a valid TEMIR account ("Account") to use our Services. Users will choose what Personal Data and third-party URLs they want to associate with their Account for the purpose of sharing with others (your "Account Information").

In any case, we cannot collect or view personal information from our clients' clients who choose to share contact information with our clients.

Temir card users can exchange contacts without restrictions, and we cannot collect information about how many times users have used the smart card.

3 STORAGE LOCATION AND TRANSFER OF PERSONAL INFORMATION

TEMIR stores its data, including Personal Information, on servers DIGITAL OCEAN located in USA.

We and some of the third party processors we engage will retain your personal and account information for as long as is necessary for that purpose or as required by law, which may go beyond terminating our relationship with you.

You can request that TEMIR delete your personal and account information at any time. Typically, profile information is retained for the period until the Account is deactivated. All personal and account information that we retain will continue to be subject to the provisions of this Privacy Policy.

4 SECURITY

The security of your Personal Information is important to us. We use commercially reasonable efforts to store and maintain your Personal Information in a secure environment. We take technical, contractual, administrative, and physical security steps designed to protect Personal Information that you provide to us. We have implemented procedures designed to limit the dissemination of your Personal Information to only such designated staff as are reasonably necessary to carry out the stated purposes we have communicated to you.

5 CHANGES TO THIS POLICY

We may amend this Policy from time to time. Use of Personal Information we collect is subject to the Policy in effect at the time such information is collected, used or disclosed. If we make material changes or changes in the way we use Personal Information, we will notify you by posting an announcement on our Websites sending you an email prior to the change becoming effective. You are bound by any changes to the Policy when you use the Services after such changes have been first posted
